Please read this declaration carefully; this form must be filled out by the **APPLICANT/Student** and verified by a witness and/or the agent (if applicable).

The information collected in this form will be used with the Genuine Temporary Entrant ("GTE") assessment interview conducted by TIIS. Please ensure that **ONLY** the applicant/Student is completing the form. Digital Signatures are accepted while witnessed. Providing misleading information and/or documents might lead to the rejection of the application.

The personal statement should be **300 words in total** (*a 2000 – character limit applies*) and be written by the applicant. Generic statements do not add value to the assessment.

The Personal Statement should cover the following:

- Why did you choose the course and why did you decide to study with TIIS
- Previous study
- Gaps in previous study
- Current employment
- Ties to home country or country of residence
- Economic situation in home country or country of residence
- Employment in a third country

You must demonstrate your claims to the above factors by providing evidence/documents to support such claim/s.
